The launch of new projects in different areas, such as the Research Grants and the Observership program, were also remarkable achievements this year.

Ao final de mais um ano com significativo crescimento da nossa comunidade, podemos dizer que alcançamos com éxito a maiona dos nossos objetivos, bem como ampliamos nossas fronteiras.

Dentre esses resultados notáveis, podemos citar os 46 eventos educacionais realizados na região, e, especialmente, o bom trabalho realizado na América Central e no Caribe. Também foi realizado o primeiro evento da AOSpine na República Dominicana, fortalecendo ainda mais a participação da organização nesta região.

Além disso, encerramos os últimos dias do ano com a finalização da estruturação do ciclo base do Programa Diploma, o qual terá início no segundo trimestre de 2012 com os primeiros participantes interessados. Sem dúvidas, este projeto será de grande valia para cirurgiões de coluna, beneficiando nossos pacientes.

Na área de pesquisa, foi feita a seleção dos projetos participantes do programa de Grants 2011, os quais serão desenvolvidos nos próximos dois anos. Também avançamos com o incremento de novos centros de referência para atender nossos membros, já que os programas de Fellowships e Observerships possuem uma procura crescente.

Para o próximo ano, a perspectiva é bastante animadora, especialmente devido à organização do curso International Interactive, o qual representa a significativa participação da América Latina como sede de eventos anuais de ensino deste porte.

Além das atividades mencionadas, iniciamos um programa de intercâmbio com a Europa através de projetos de cooperação ibero-americana para 2012 e 2013. Esses programas fortalecem a relação de proximidade e de reciprocidade com o velho continente, de maneira similar ao que foi feito com a América do Norte e que será em breve realizado com o Leste Asiático.

Em nome do Conselho Regional, agradeço a todos aqueles que de uma maneira ou de outra contribuíram para atingir estas importantes conquistas e convido os demais a fazerem parte do incrivel mundo da AOSpine.

The exciting prospect for next year of the set up of the International Interactive Courses corresponds with the participation of Latin America hosting these annual educational events.

In addition, we have started an exchange program with Europe for 2012 and 2013 through Ibero-American cooperation projects. The proximity and reciprocity with the European continent will be enhanced, as was the case with North America and which will soon follow with Asia Pacific.

On behalf of the Regional Board, I am grateful to all those who helped, in one way or another, make all these achievements possible and I would like to encourage and invite others to take part in the amazing world of AOSpine.



#### AOSLA Community Development Workshop



For the first time, the Latin American Community Development Officers met to discuss a variety of subjects including their role definition, area of work, the importance of creating alliances with other local spine societies, ways to publicize new projects such as the AOSpine Diploma, Young Surgeons and promoting membership benefits.

The involvement of local officers was an important step in initiating the implementation of the strategic and operational plan for Community Development International.

The meeting was divided into two parts: the first one consisted of presentations from the AOSLA Boards on Research, Education, Regional and International Community Development projects, the regional action plans for 2011, and the services and support offered by the Curitiba office.

Further highlights of the first part of the meeting included the presentation of new projects such as the AOSpine Diploma and Young Surgeons, as well as presentations made by the Community Development Officers on the strengths, weaknesses, opportunities and threats in their own country.

The second part consisted of workshops, in which the participants discussed various issues in smaller groups, suggesting how to move forward and setting up an action plan. 
The meeting proved to be very fruitful with

### Education-Ortho officer's word

Dear friends,

As Education Ortho Officer, it is my wish to send you my warm and kind regards at the end of 2011. I thank all of you who are part of the AOSpine family for your support, be it as a Participant or as Faculty in our diverse educational agenda.

This year we, once more, achieved the execution of several courses, symposia and seminars at basic, advanced and masters levels. We also successfully concluded the advanced level Virtual Course, with a very high rate of participation at around 150 students in each course. Furthermore, we carried out very successful and high quality cadaver courses in La Plata, Monterrey and Santiago de Chile. For the first time, we have reached Cuba with a basic level course. The permanent interest of the spine community, from both orthopedic and neurosurgery fields, gives us the necessary energy to continue on this path and drives us to continue to improve and renew.

It is precisely because of this need to improve, that we initiated new educational projects this year with appropriate levels, similar to the ISO certification of the companies. In the next items I will briefly detail the actions undertaken in this direction:

- Implementation of the AOSpine Curriculum. This refers to a list of educational competencies and objectives based on the four AO principles, which are divided into six pathology groups: Trauma, Deformity, Tumor, Degenerative, Infection and Metabolic-Inflammatory-Genetic. The main objective is to assure the delivery of these competencies at the different levels of specialization basic, advanced and masters.
- We very successfully began the implementation of AOSpine Curriculum in basic courses in Recife and La Paz. Together with the implementation, a self-assessment questionnaire is taken online, before and after the course, as a manner of evaluating the impact of the educational event on the students. I would also like to take this opportunity to urge everyone to complete the assessments in the requested time.
- We are finishing the first cycle of the Diploma Program, which consists of an online and face-to-face course which certifies those participants who complete it with an AOSpine Diploma and are approved in the final test. This program, which is unique in the world, will be launched in the first quarter of 2012. In accordance with the AOSpine structure, it is composed of three levels of complexity: principles, advanced and masters. It is also based in the four AOSpine principles and it is divided in the same six pathologies as AOSpine Curriculum, with the addition of Anatomy and Biomechanics. The educational program will be available for whoever wants to be enrolled, with the sole requirement of being an AOSpine member.
- For 2012, a large numbers of courses and seminars are expected, including a Davos Course outside Davos, to be held for the first time in Latin America, in Buenos Aires. This event will expect to feature the most important specialists in the world.

Finally, we are not expecting any changes in regard to the selling of Synthes to Johnson & Johnson, and this will remain so for the next few years. Our work resides in our quality in education and our position as the number 1 in this, making AOSpine a desirable and important organization for any company. This is the way chosen by the Board to assure the future of the organization.



#### **AOSpine Course: Live Tissue Surgery**



Now in its fourth edition, this course was held in order to offer as much opportunity as possible to practice spine surgery on animal specimen. The organizers of this successful course developed a module for posterior approaches giving the participants the opportunity to practice complex osteotomies and vertebral resection procedures.

The anterior approach to the thoracic and lumbar spine was also practiced. This last method is no longer an exception in complex spine pathologies and is now used in the daily routine of the surgeon.

The Faculty group and participants discussed the risks of these procedures, possible complications, as well as immediate to late post-surgical management.

#### Diploma Program


#### **Purpose**

This year AOSpine Latin America has been emphatically working on a new educational project, entitled Diploma Program – Continued Education in Spine Surgery. The main goal of this project is to implement a long-term educational program which will provide a Diploma to those who complete its activities and are approved in a final test.

#### **Program framework**

The Diploma Program, to be launched in the second trimester of 2012, will be a complete, progressive and ground-breaking educational plan focusing on spine pathologies. The program will consist of both online and face-to-face activities in order to provide the participants with a thorough approach in the field of spine surgery and pathologies.

The material is produced by renowned Faculty from the Latin American with the support of the AOSLA office. The program will be composed by three cycles, each one of them



compounded by eight modules, in accordance with the AOSpine Principles and Curriculum. Every cycle will have correspondent face-to-face and online activities, the latter being available at our platform. At the end of the three cycles, participants will be awarded with an AOSpine Diploma after being approved in a test.

#### **Recent activities**

In 2011, the AOSLA team and Faculty used extensive didactic and graphic text processing to develop the material to be released online (i.e., written topics, interactive and evaluation cases and evaluation questions). The AOSLA office was also responsible for adjusting the material to an online, interactive format, as well as uploading it to our web platform.

In November, concomitantly to the AOSpine Symposium: Complications and Controversies held in Bogota, Colombia, in November 19th-20th, the project Task-Force had the opportunity to arrange a meeting to discuss the development of the educational plan up to that time. This very productive meeting allowed the team to define the next project steps for Cycles 2 and 3 and to prepare the program launching in 2012.

#### AOSLA Curriculum Pilots Implementation

#### **Purpose**

This year several pilot events of the AOSpine Curriculum implementation were held worldwide with the purpose of integrating the curriculum—as well as the AOSpine Principles—into our educational activities. The data gathered and the achieved learning outcomes were analyzed by the Curriculum advisory group in order to guide the future steps of the project and develop key resources.

#### **Characteristics**

For this stage Educational Directors (EDs), Chairperson, Faculty, Participants and Project Managers were engaged to perform key roles in the implementation using the following Curriculum components:

This pilot was focused on spinal trauma

and its content was aligned with the competencies and key learning outcomes of this pathology. Participants completed a pre-course self-assessment questionnaire, the data of which was used by the faculty at the pre-course meeting to identify the audience needs, in order to adjust the lectures/discussions to meet these demands. They also concluded the three month follow-up questions on their intended practice change, and the collected responses showed a lot of engagement and commitment to implement the content acquired into their daily practice.


This Seminar, focusing on the degenerative pathology of the spine, was the second pilot implementation of the Curriculum in Latin America. The Chairperson Juan Marcelo Sea Aramayo together with the Educational Director Pablo Vela and Regional Faculty Germán Ochoa, worked to motivate the 38 participants to complete the pre- and post-

assessment. This data was highlighted by the high level of the discussion held in the Faculty lunch meeting

regarding the assessment and its results. Both participants and Faculty demonstrated openness and involvement with the program, engaging in high-level debates and offering very promising responses in the commitment to change evaluation.

Our Reference Centers and their respective directors have played an important role during the execution of our Fellowship & Spine Centers project, staying up to date with every activity and procedure proposed for 2012.

Currently we have six centers distributed in the region (in white) and seven centers currently in the application process (in green):




# Fellowship & Observership


We have concluded this year with a total of eleven new fellows, which totals 78 fellows since 2006. Based on the restructuring of the application procedures, the Fellowship & Spine Centers project has been developed with the purpose of selecting the most adequate applicants for the program through a score system. The project also aims at measuring the competences of the fellows through a pre-/post-fellowship test.


Furthermore, this year we initiated the Observership program, for which we have already received the first three participants. Based on the number of applications received, our expectation is to reach the number of five observers this year. For 2012, we hope to continue to offer this training with a larger number of centers involved in the region.

As in previous years, the fellowship program has continued to be of great interest to our members aspiring to acquire new tools and knowledge in spine surgery. This is particularly evident in the increasing number of applications processes received in 2011.

Due to this, our Fellowship & Spine Centers project has implemented a new application process, which has structured new steps for the candidates. The new process offers all the applicants from different countries the same opportunities in entering an AOSpine training program in any center of the region or the world.

#### Report from an AOSPINE FELLOW

My name is Allan Masashi Guimarães Kato, I went to Med School at the Federal University of Amazonas, Orthopedics and Traumatology at University Hospital Getúlio Vargas, also in Amazonas. In 2010, I completed my first year in spine surgery specialization at Pequeno Príncipe Hospital in Curitiba, and in 2011, I participated in AOSpine's fellowship program at the University Hospital Cajuru, which was coordinated by Dr. Luiz Vialle and Dr. Emiliano Vialle.



My expectations regarding the program, which were already quite high, were surpassed. In my opinion, the excellence of the program lies within the practice of the weekly meeting, which I will try to describe briefly. The meeting is divided into three main parts: the first one is a scientific revision for updating the medical literature, which the staff elevates to a surprisingly high technical level. Besides the spine surgery group, the neurosurgery group also participates. The second part is dedicated to the discussion of the patients' cases who were operated during the previous week, from which we can draw valuable conclusions – I consider this the integral part of the meeting. Finally, the third part is composed of a presentation of the surgical cases scheduled for the following week.

The surgical activities that I have experienced comprise, both quantitatively and qualitatively, the foundation of spine surgery, trauma, degenerative, deformity and tumor. The technical quality of the staff, the respect for the patients and the attention dedicated to teaching the fellows are renowned and have already been mentioned by other fellows who have participated in the program.

I come from a geographically isolated area in Brazil, located in the heart of the Amazon Forest – the city of Manaus in the state of Amazonas, which has a population of around two million people. I will be returning there soon and will have the opportunity to put all the concepts I was taught into practice. For all of this, I will be forever thankful to masters Dr. Luiz R. Vialle and Dr. Emiliano Vialle for the opportunity they gave me during my participation in the AOSpine training in Curitiba, Brazil.


#### Fellowship & Spine Center Project Management 2012

by documents and guidelines in Spanish and Portuguese, allowing for easy access and comprehension by the applicants.



Spine Centers/Fellowship Guidelines




Spine Centers/Fellowship Application Forms




Spine Centers/Fellowship Evaluation Forms

In 2011, maintaining a trend initiated in previous years, we dedicated our time and efforts to invest in education for research and financing smaller projects, in an attempt to incentivize the growth and strengthening of local investigations.

We were glad to present a Good Clinical Practice training in Recife, during the AOSpine Principles Course, which attracted a significant number of young surgeons interested in improving their knowledge about clinical research. We also had a very satisfactory experience with the opening of our first call for research grants, which awarded USD 30.000,00 to very promising basic science and clinical studies projects, supporting and promoting the investigators at a local level.

Furthermore, larger research projects such as the SRS22 continued to enroll patients and collect new data, generating important and valuable information which will soon be published and contribute to the implementation of the SRS22 questionnaire in Portuguese.

The mission of the AOSLA Research body, during the last three years in which I had the honor of being the regional Officer, has been to promote education for research, to support both inexperienced as well as senior investigators in the best possible ways, and to promote the growth of a medical research culture and knowledge throughout the continent.

I am very pleased to have reached the end of my mandate with such relevant achievements for the area – research trainings, clinical studies, grants – and with the certainty that the work jointly developed in these years will be carried on by future AOSLA Research Officers. As of March of 2012, I will leave my position with the hope that our work contributed to our members getting involved with Latin American medical research, be it through education or through the performing of investigations.

# Research Projects 2011

#### Good Clinical Practice training in Recife

The training entitled "Clinical Research: From Idea to Publication" took place on June 10th 2011 during the AOSpine Principles Course in Recife, Brazil. Ivo Schauwecker, Senior Project Manager Study Planning at the AOCID department of the AOFoundation, coordinated the training and held a three hour long lecture about the basis of clinical research. The activity was part of an eight hours training about clinical investigation, which has already been held in places such as Singapore, Germany, Austria and Hong Kong.



The training focused on the basis of clinical research and aimed at deepening the knowledge of the participants on clinical research, as a way of increasing awareness about the processes involved in conducting an ethical and legitimate investigation.

The lecture approached subjects such as the guidelines for Good Clinical Practice, the Declaration of Helsinki, the ISO 14155 standard and local regulations. Furthermore, topics such as planning a clinical investigation study, the scientific background of research, study conduct and publication were also discussed. Ivo Schauwecker attracted more than 25 people to this optional training, providing a large amount of valuable information for the audience, with a very detailed presentation. The participants received a specific certificate from AOSpine for this activity.

By bringing this training to Brazil, AOSpine Latin America expects to support the development of areas such as research and technology, in order to provide to our community with specific programs that might contribute to the high quality academic formation of our professionals.



#### Research Grants 2011-2012

The call for applications for our research grants program was open from July to October and received 18 applications from a wide range of Latin American countries (Brazil, Chile, Mexico, Argentina, Colombia and Peru), containing very diverse backgrounds and research topics.

Two projects were chosen to be awarded with the USD 30,000.00 grant, which will be paid over the course of the next two years in accordance with the investigators' research chronogram. During the next two years, the awardees will report to AOSpine Latin America periodically, providing the investigations findings and progress on a regular basis. By the end of the contract period, a publication will be released with the final results of the studies.

The investigation projects sent to AOSpine were analyzed and evaluated by a highly qualified selection committee, composed of different research officers in the area, as shown below:

This initiative represents an effort to support our members in getting involved with clinical and scientific investigations, providing both administrative and financial aid to develop spine-related studies in our area.

#### SRS22




The SRS22 project, coordinated by Carlos Tucci, consists of the validation of the SRS22 questionnaire of Idiopathic Scoliosis to a Brazilian Portuguese version. The process is made through a series of translations of the inquiry into Portuguese and its application on patients with scoliosis in order to evaluate the legibility degree of the document.

This year, the project had an extraordinary development, hitting the mark of 70 patients enrolled, which represents a quantitative leap in the data collection and analysis. The next steps are the in-depth statistical analysis of the data and the subsequent publication of the results in a scientific study. The final analyses should be expected for the first quarter of 2012 and will be followed by a scientific publication.

The study is of great significance, as the translated questionnaire will be the first and only tool in Brazilian Portuguese to evaluate the life quality of patients with scoliosis. The centers involved in the study can be seen in the following table:






In 2011 we maintained our position as the third largest region in term of membership numbers . Next one may find graphs to further illustrate the numbers of each AOSpine region.




#### 2012 Calendar


