

Dear Friends.

We are only a few weeks away from the end of 2013 and it is a pleasure to look back and acknowledge that this has indeed been a fruitful year, filled with many productive administrative and academic activities. During this year, AOSLA completed the constitution of a new Regional Board with the elections for Chairperson and Education Ortho, Spine Centers & Fellowships and Community Development Officers. This is the beginning of a new phase for the region and, with the support of all our members, we expect this change to be productive in all areas. In the academic field, a large number of Courses, Seminars and Symposia were performed, applying the principles of the AOSpine Curriculum. Besides our traditional Virtual Course, with its continued large acceptance, this year also saw the development of several cadaveric courses with great results, inspiring us to continue performing and improving these activities.

Another positive aspect in the educational area was the beginning of the second cycle of the Continuing Education Program – internally known as Diploma – with the hope and goal that the Program will continue to be enjoyed by a large number of colleagues. An equally important factor is the continued promotion of the formation of Faculty members and course Chairpersons, for which we will continue the type of activity developed so far, be it virtual or face-to-face.

Taking the great importance of Research into consideration, this year's AO Retreat in Lima involved all specialties of the region in a discussion on publications. The event identified our strengths and weaknesses and built on the cooperation and collaboration of the AOSLA local Chapters and Research Officers, as well as the AOSLA Office, to push research activities with the goal of presenting the results of our studies at the next Global Spine Congress in Santiago, Chile, in May 2015.

Communication is a factor of special interest for this new Board, especially with the local Chapters. We have therefore started a visitation program to help transmit the new ideas or action policies to local Officers, also making it possible to listen to their opinions and get acquainted with their issues and difficulties. This allows us to better support them in solving their problems, and opens the door for more effective and adequate decision making in the promotion of their growth. Furthermore, we have been building important relationships with local Medical Societies throughout the region, helping to develop joint seminars and symposia, which are already generating excellent results. We expect this synergy to deepen even further, especially in regard to researches, which will strengthen our position at an international level in the long-term.

In the Community Development area – which is focused on analyzing and improving projects related to membership, among other things – we have been able to maintain our membership rates on average thanks to the support of the community. However, due to a drop out tendency, we will be focusing our work on developing new projects to keep our colleagues engaged in the organization and benefiting from AOSpine.

Although I feel there is much more to say, I would like to reserve this space for each area's responsible Officer to express their personal vision. I would also like to wish everyone happy holidays and happy new year in the best of health and in the presence of your loved ones.

This program allows successful applicants access to the most up-to-date developments in spine surgery based around the AOSpine principles, with the purpose of transferring this learning experience to patient care.





Fellowship & Observership Program



Participation of fellows according to country of origin 2006/2013





Research officer's word

Dear AOSpine members,

An entire year has now once again passed quite quickly, and fortunately I had the pleasure of continuing to perform some fascinating work as AOSpine Latin America Research Officer. During this time, I have had the opportunity to meet all kinds of interesting people, whose brilliant ideas inspired me to contribute to the improvement of research in Latin America. Considering all this support, I would like first of all to thank all these friends for their collaboration with the organization.

One of our main achievements in 2013 was the development of two multicenter projects performed by Latin American researchers, which aimed at evaluating the local scientific production. These studies were very important for assessing the research being produced by spine surgeons in our region, their main areas of interest and journals of publication, as well as the difficulties usually encountered when conducting a scientific project.

These projects helped identify some of the reasons that contribute to the limitation of scientific publications by Latin American doctors, thereby making it possible to develop and implement strategies to change these circumstances. One of these strategies is the investment in quality education in research, to increase both quantity and quality of scientific publications. As a result of this

plan of action, several research education symposia and meetings were developed in different countries. Given their success and the overall positive response from the community, activities of this type will be maintained, strengthened and increased in the years to come.

In addition to these activities, we have started an international project focusing on mentorship, which is offered to all AOSLA members. A good example of this successfully implemented project was a study which had the AOSpine Research Chairperson, Daniel Riew, as their mentor. The project started with a call opened to AOSLA members and authors from all over Latin America participated.

A side project was developed in which a database of all AOSLA members interested in research was compiled through an online survey. The main objective was to map those doctors in Latin America who would be interested in developing research, building a network for future team work for specific projects based on participants' interests and abilities.

The AOSpine community will be informed of ongoing research projects and their progress, including information on how to

participate in the studies. AOSLA is also developing projects to assist with language and statistical consultancy for those members interested in developing a study, so as to support local investigators. The implementation of a group of reviewers to assess potential investigation projects will help strengthen these projects. Finally, the creation of a research fellowship is an integral part of our plans for the future, providing further support for research centers and investigators in the region.

As Research Officer, it has been an enjoyable challenge and opportunity to help identify and stimulate possible research groups, promoting the exchange of experiences between researchers from the local Chapters, and being able to offer the tools for inter- and multidisciplinary work. There is no need for prior knowledge to conduct a research study; only the drive to do so.

It is of utmost importance to understand that the goal of scientific training is not only to publish papers, but also to offer improved patient care through the collection of relevant data. Through research, we are able to show the community and health providers which treatments, materials and diagnoses are most effective for our patients. We will continue with our pursuit of improving spine surgery research in Latin America, providing the global spine

community and their patients with excellent work, regardless of the difficulties faced in the region. We will have the chance to show the results of our research projects at the Global Spine Congress that will be held in 2015 in Chile.

Research Grants

The AOSpine Latin America Grants Program is currently supporting four projects in the region – two of them beginning in 2011, and two in 2012. All projects have been receiving regular stipends from the organization to develop cutting-edge research in spine surgery in Latin America. These projects – both basic science and clinical studies – were awarded the grant after a meticulous selection process

conducted by the AOSLA Selection Committee.

Research projects

International mentoring and multicenter study

In 2013, AOSLA initiated the development of an international mentoring and multicenter project for the first time. The study, entitled "Surgical planning and neurologic outcome after anterior approach to remove a disc herniation at the C7–T1 level in 19

patients", was performed in participation with different spine surgery centers in Latin America. Daniel Riew, from the Washington University in Saint Louis, USA – and also AOSpine Research Chairperson –, was the international mentor in charge of the project.

Results

Data collected from 19 cases indicated that the standard anterior cervical supramanubrial approach can be used for most C7-T1 discectomies and fusions. Despite the fact that this is a single-level discectomy and fusion, the participant researchers consider that a stand-alone cage would be inadequate. Taking this into consideration, the use of an anterior cervical plate is recommended. Post-operative and radicular pain disappears immediately and, in the majority of the cases with intrinsic hand motor deficits, normal motor function is re-established.

The project has obtained peer-review acceptance in the Spine Journal, in press.

Fractures A3

Objective

The complete name of this international project, normally referred to as "FA3", is "Comparison of surgical versus conservative treatment of AO Type A3 thoracolumbar fractures without neurological deficits". Its main purpose will be to evaluate whether patients with thoracolumbar fractures, without neurological deficits, exhibit a faster rate of recovery and better improvement of functionality when surgically treated, in comparison to patients submitted to conservative treatment. This study specifically aims to measure whether surgically treated patients have a higher average difference in their scores on the Roland-Morris Disability Questionnaire (RMDQ), between baseline and a six week follow-up, than patients submitted to the conservative treatment. A total of 140 patients with thoracolumbar fractures will be assigned either conservative or surgical treatment, depending on the surgeon's decision, in order to collect and assess the necessary data.




Research database survey for AOSLA members


Objective







On March 1st, the Meeting for clinical research took place at the Congress of Spine Surgery in São Paulo, Brazil.


Objectives

From May 1st–3rd, the AOLAT Retreat in Lima, Peru saw the participation of over 90 members of the Latin American Faculty from three clinical divisions.

Objectives

The participants were able to share their experiences and knowledge on the relevance of medical publication in the region. The event was a unique opportunity for the 26 AOSLA Faculty members to continue developing the educational work and strengthen the network for knowledge discussion.

On May 10th–11th, AOSLA carried out the AOSpine Research Seminar: New era in clinical research in spine surgery.

Objectives

This seminar focused on bringing relevant knowledge about research, stimulating joint scientific activities through the exchange of experiences. Furthermore, it intended to identify the active research centers in the region, providing education and qualification regarding clinical research.



In June, another educational research activity was held at the 16th Congresso Gaúcho de Educação Médica, which saw the participation of 600 students from Medical Schools across the Southern region of Brazil.

The Congress took place at the Universidade de Caxias do Sul with Asdrubal Falavigna, AOSLA Research Officer, as the Chairperson of the activity.



Also in June, the AOSpine Pre-Congress Advanced Seminar: Evidence-based medicine was held the day before the AMCICO.

Objectives

The event aimed at covering the foundation of evidence-based medicine, as well as featuring discussions about developing, writing and publishing scientific articles. Both the Seminar and Congress were held in Mérida, Mexico.

In September, the AOSpine Research Seminar: 1st Journey in clinical research from the Hospital Cristo Redentor took place in Porto Alegre, Southern Brazil.

Asdrubal Falavigna, the Chairperson of the activity, created a space for the discussion and exchange of experiences related to clinical research themes, supporting researchers in the development of the basic knowledge needed to conduct studies and giving tips on how to overcome the difficulties in this process.



Virtual meetings

Objective

AOSLA is currently holding online meetings with all local Officers, members and research course participants who are interested in a larger involvement in research on spine surgery. Through these meetings, the organization expects to continue to nurture the upcoming research groups and further push multicenter studies.

The main objective of the virtual meetings is to exchange ideas and raise awareness among the local Officers about the different projects being developed in the region. These steps are fundamental to the formation of clinical and experimental study groups, which will help to produce relevant research in the future. These meetings also perform a very important role in informing the AOSLA members interested in research about the status of the ongoing projects, giving them the chance to actively participate in the studies.

AOSLA Research book: "Principles and basic steps to perform scientific projects and to publish"

Objective

As a result of the previously described activities, AOSpine Latin America Research identified the necessity of improving basic knowledge among members from the region. To this end, AOSLA is supporting the production of a book which will serve as a basic assistance tool for research in general. The book will be coordinated and edited by Asdrubal Falavigna, AOSLA Research Officer, and José Maria Jimenez, Mexico Research Officer. All the local Research Officers from the Latin American Chapters have been invited to contribute in the authorship of the material.

The book is composed of 28 chapters, divided into three sections: the first refers to the development of an idea; the second is focused on the reasons behind the performance of scientific studies and publishing; and the third focuses on how to publish. The volume will be available in Portuguese and will also be translated into Spanish.




Membership





Education Ortho and Neuro officers' word

Dear Friends,

We would like to take this opportunity to warmly welcome you as members of the AOSpine family and thank for your participation in our educational activities. We would like to highlight the most significant achievements of 2013, which helped strengthen the bonds across the AOSpine Latin America community and further the progress in the region.

The interest and engagement in the educational activities offered by AOSpine has continued to grow: the total number of events increased by 35% in comparison to 2012 and saw a 15% increase in the number of participants. One of the main highlights was the Principles Course organized by the Brazilian Chapter, in which a new format was used, promoting more interaction through discussions in small groups.

We also carried on with a very successful implementation of the AOSpine Curriculum in 100% of our events. This accomplishment was a result of the Faculty development projects from previous years, which guaranteed an effective use of the Curriculum guidelines in exploring the competences and learning outcomes to be used. The figure of the Virtual Educational Advisor also ensured the use of these guidelines in smaller events, such as seminars. From now on, the Education team will be focused on developing new program templates based on a modular framework, as well as developing tools for quality assessment.

This year also saw pilot implementations of the AOSEC standardized templates for Principles Courses in selected events. These templates assist the Chair in preparing a standardized course, based on clinical cases or lectures. The templates are a useful, global and very dynamic tool, and the feedback received in these courses will help AOSEC consolidate this concept for its official launch in 2014.

The constant work with Faculty formation continued to be developed through Faculty Training courses in different countries, always aiming at providing the highest possible quality for our community. In February, Chairperson and EA trainings were held in Lima, providing the Chairs and EAs in charge of activities in 2013 with the adequate training to perform their role.

Furthermore, AOSLA continued with the successful formula of the Virtual Course, already in its sixth edition. The course has become an institution in the region and enjoys great recognition from the participants, bringing quality education to surgeons all across Latin America. The system innovations allowed the two courses (Principles and Advanced) to be an even greater success, providing participants with a high quality transmission and lots of opportunities for interaction.

Another relevant activity is the Continued Education Program, which saw the first group of participants concluding the first cycle

and beginning Cycle 2, which was officially launched in September. In order to reinforce the Program's structure, an official agreement has been signed with the Universidad Nacional de La Plata (Argentina) to develop a range of integrated activities related to the Program, including the issuing of joint certificates. The Program Director, Néstor Fiore, and his team will be working intensively to develop the final cycle of the Program and strengthen the interactivity among participants and Faculty members in 2014.

This year we were also able to finalize the development of our Faculty Database, an information system in which data about Faculty's activities, interests and fields of expertise are compiled and processed. This tool will allow the organization to track and follow up on Faculty activities and performance, presenting an important end-use for the planning of future activities.

Finally, it is fundamental to thank everyone – participants, Faculty and Board members – who collaborated on these projects and enabled their development, offering a sincere and inestimable commitment to our activities. We would like to express our gratitude to our friends at the AOSLA Office, for our work and success would not be possible without them, and to also welcome the new members. We are sure that the organization will continue

to evolve and move forward thanks to the commitment of all of you who are a part of our community.



The AOSpine Curriculum is a learning framework which encompasses content from six areas of spine pathology. Knowledge is delivered based on competencies and learning outcomes, providing surgeons with the most relevant tools to perform effectively across the different areas of spine surgery.

This framework is comprised of three progressive levels (Principles, Advanced and Masters) that ensure an effective structure for developing a progressive learning path for the participants of AOSpine educational activities.







The following graphs present the overall percentage of participants who took part in the assessments and surveys during the implementation courses, in comparison to the percentage of participants who did not complete these questionnaires. These percentages are in regard to the total number of participants taking part in the implementation courses (253 participants).







Overview of the full implementation courses

Continuing a tendency from previous years, the largest difficulty in the implementation process remains obtaining satisfactory response levels for the self-assessments (both pre- and post-course). Nonetheless, a significant increase can be noticed when comparing the results generated in 2013 to the rates from 2012. The post-course self-assessment saw an increase of 15% compared to the previous year (from 23% to 38%), and the Commitment to Change increased from 75% to 87%. As for the pre-course self-assessment rates, a slight increase was also observed (from 44% to 52%).

The analysis of the alignment of programs to the Curriculum has shown that progress has been made in regard to the indication of competences and learning outcomes to be used in each course. However, it is important for the Chairs to continue developing the habit and culture of creating specific learning outcomes for every activity performed, aiming to provide the Faculty with a simple and easy-to-use guide on how to develop their lectures.

Next year the Education team will be working on structuring a more efficient communication process between EAs or VEAs and Chairpersons in order to achieve these goals, as well as maintaining the successful work in the EA and Chairperson trainings and developing program templates for both principles courses (standard) and advanced courses (modules).

Support projetcs

This year has seen the region emphatically working on implementing some new projects to give adequate support for the Curriculum implementation processes. These projects will be briefly described in the following.

Chairperson and Educational Advisors trainings

At the beginning of 2013, all Chairpersons in charge of educational activities for the year were invited to participate in the new Training for Chairpersons, in Lima. Supported by Faculty members and the educational team, the Chairs had the chance to get acquainted with the AOSpine Curriculum, identifying participants' needs and linking the corresponding learning outcomes to the activities to be developed.

At the same time, a training for Educational Advisors also took place in Lima, which included twelve new EAs from the region. The format of the training focused on a clear definition of the learning outcomes for every activity, as well as their implementation in accordance to the Curriculum guidelines.

Both trainings presented a valuable opportunity for our Faculty members to learn through practical and interactive activities, obtaining tangible results in the educational activities at both an organizational and content-based level.

Virtual Educational Advisor (VEA)

In 2013, we were also able to successfully implement and consolidate the position of Virtual Educational Advisor in activities which do not have an on-site EA (usually seminars). The main objective of the position is to support the Chairperson with the alignment of the educational program to the Curriculum guidelines, providing orientation via e-mail or conference calls.

Chairperson form

In 2013, 100% of our events saw the implementation of the Chairperson form, which assists the Chairs in the selection of which competences to use in the program of the educational activity.



Program templates

The program templates represent a global tendency at AOSpine to develop a structure for long-term, continual learning throughout all activities. This structure must be in compliance with the international educational platforms, with excellence in education as its objective. The use of program templates, the alignment of contents to the Curriculum framework and the Continuing Education Program are some of the tools which provide support for the Chairpersons and Faculty members when performing the activities. These tools assure that all activities developed by AOSpine are in accordance with the highest standards of educational quality, always based on the needs presented by our community.

• <u>Standardized templates for Principles Course</u>

AOSEC created two templates with the objective of preparing a global standard course syllabus for the Principles Courses – one based on clinical cases and another based on lectures – with modules and specific learning outcomes, as well as guidelines for the Faculty on suggested practices, educational methods and a support package.

The year 2013 saw a world-wide pilot implementation of these templates, including the following events in Latin America.



The Education Commission has been working on evaluating the results of the pilot implementations. The report on the results is expected soon, with the aim of improving the official implementation in the regions in 2014. The main goal is that all Principles activities next year will be formatted according to one of the proposed templates.

• Modular templates for Advanced Courses

The AOSLA Education team has been working on modular templates for the advanced level activities in the region. These templates will be aligned to both the Curriculum and the Continued Education Program, providing a more structured framework for the future activities. The templates suggest a series of themes to be developed in different types of educational events, organized in accordance to the most relevant spine pathologies. The current model being developed is composed of 21 modules, whibe combined according to the event's proposal and objective.

All modules take the same time, so they can be combined as necessary.

Innovation

The Brazilian Chapter moved to develop a new pilot model for Principles Courses so as to improve the impact level of educational activities on surgeon's daily practices and the interactivity of the courses, thereby bringing the participants and Faculty closer together.

The general structure of this pilot includes materials for pre-course study, an introductory module with clinical cases and two or three short lectures (of seven minutes length each) which help emphasize the main concepts used in the discussion. Participants are divided into two separate groups, each with a moderator presenting clinical cases, and then divided into subgroups (six people

per Faculty member). The discussion of the clinical case is conducted in the small groups, with the support of the assigned Faculty member, with one representative of each group presenting some key points to be discussed with the moderator and the other subgroups later on.

According to the local Chapter, this model offers advantages such as: improved learning retention (through case discussion); less anxiety for participants, as discussions are conducted in small groups; closer contact between participants and lecturers generating higher learning satisfaction; and improved interaction during the activity.







Action items for 2014

The following projects will be developed and implemented in 2014 with the objective of continuing to improve and solidify our educational basis.

Accreditation

AOSLA will be working on the establishment of agreements with academic societies or regulatory entities to accredit our educational activities, so as to guarantee higher standards in terms of recognition for our educational activities.

Standardized pre- and trans-course meetings

Besides the daily assessment of the event with feedback sessions, we will be working on the implementation of a meetings guideline with the purpose of conducting more effective pre- and trans-course meetings, helping to ensure the revision of learning outcomes and audience's needs.

Program templates

We will be implementing and consolidating the use of program templates in Principles Courses, Advanced Symposia and Seminars with the objective of providing a standard quality education based on the AOSpine Curriculum.

Assessment process and Faculty selection

Aiming at conducting a more efficient Faculty selection for different educational activities, we will be working on the revision and adjustment of assessment tools for events – both at a participatory and Faculty level. The process of elaborating the educational plan in the region will also be reviewed.

Continuing Education Program

In 2012, AOSpine Latin America proudly launched its first educational program focused on doctors' continued education, exclusively for members. The Continuing Education Program (internally also known as "Diploma Project") was successfully implemented as a progressive three-year education plan, based on the pathologies of the spine. The contents are delivered both through face-to-face and online activities and are aligned to the AOSpine Curriculum guidelines.

In 2013, the first group of participants finished the first cycle of studies and prepared to begin Cycle 2, which was officially launched this September.



Cycle 1

Progression

The first Cycle of the Program completed its first year online this August. Since its launch, 350 people have requested to be enrolled in the Program's Cycle 1, taking part in the activities provided by the 23 topics of study, their respective exams and more than 50 interactive clinical cases. The materials are available on a Desire2Learn online platform, which also provides online forums and assistance to participants' through e-mail. Over 30 participants have already finished the initial activities, having passed the exams and obtaining a solid basis for their continued studies in the following cycles.

The Cycle 1 of the Program is constantly progressing, having its activities reassessed, revised and improved, in order to obtain the best possible educational outcome. These efforts are already generating beneficial results, as illustrated by the positive comments received from participants on a regular basis.






Participants' profile



Similarly to Cycle 1, registration for the new cycle has been permanently open for AOSpine members, and Cycle 2 has already seen more than 60 participants enrolled. Many of them have successfully completed Cycle 1 and are now moving forward with their studies, aiming to obtain a complete certification in the future.

Certification and accreditation

Following the negotiations with the National University of La Plata (UNLP), Argentina, in 2012, the project Task Force finalized an agreement between the academic institution and AOSpine Latin America in 2013. The agreement establishes a range of activities to be developed between the UNLP Medical School and AOSpine, focusing on the joint certification of the Continuing Education Program.

Starting in 2013, the completion certifications of the Program will be issued by the UNLP under the title of "University Qualification Course on Spine Pathologies". This joint certification will be issued after the completion of the online component of every Cycle and after the successful completion of the entire Program (three online cycles plus face-to-face activities).

This achievement is not only of great relevance for administrative purposes, as it highlights the academic quality of the project, but is also important for the Program's participants themselves, who will obtain a certification which meets the educational standards of the National University of La Plata.



Activities for 2014

The next steps of the Program are focused on finalizing the elaboration of the Cycle 3 materials and reassessing and improving Cycle 1 and Cycle 2 contents. New learning strategies are already being discussed and studied by the project team with the aim of taking the educational program to the next level in terms of content update, interactivity, participants' support and use of new information and communications technology. Besides continuing the work on the first two cycles, AOSLA has been focused on the launch of Cycle 3 in the first half of 2014.

Faculty development

The investment in Faculty education and training is one of the key elements for successfully executing events in the region, as it constitutes an important platform for the development of the highest level of quality for our educational activities.

Faculty Training

Our current model of Faculty training has been designed to improve the educational skills, knowledge and experience of the AOSpine Faculty members. In our training programs, participants are able to explore different teaching methods through the interaction with a team of medical education experts.

In 2013, AOSLA presented a newly formatted pilot training, named Mini T4F – extended pre-course, for the first time. This model is divided in two modules:


AOSLA Faculty Database

Most of the events developed in the area provide participants with the opportunity to give feedback about the lecturers, their performance, the quality of the contents presented and the importance of the activities for their daily practice, as well as giving the opportunity to comment on the organizational aspects of the event. The evaluations, conducted as questionnaires or through audience response systems (ARS), make it possible to compile important data about the strengths and weaknesses of our events, enabling restructuring in order to increase quality whenever needed.

Since 2012, AOSpine Latin America has been working on a tool to compile, organize and process this data in one single system, which can then serve as a trusted source of information on the events and the Faculty members. This year finally saw the implementation of this tool, encompassing all data collected on AOSLA events since 2009.

The main objectives of this information system are to provide an easy process for filing the data collected in the educational activities; to run an automatic report on the performance of the Faculty members in the events; and to obtain an objective evaluation of every Faculty member based on the EA's comments. Furthermore, this database also includes specific information about Faculty demographic and professional profiles. This tool wil allow for more efficient and precise Faculty selection for every educational event, promoting a significant optimization in the allocation of human resources.







Educational Activities 2013 Brazil

This year, AOSpine Brazil focused on the creation of a model of activity which could be adjusted to participants' needs and requests at every educational level. 

Virtual education

Thanks to the constant support and collaboration of the Latin American Faculty, we successfully completed the sixth consecutive year of the AOSLA Virtual Course. This year featured an Advanced Course, composed of four modules of two hours length each, and a Principles Course, composed of two modules of two and half hours length each.

This model of educational activity allows AOSpine members to either get directly connected from their homes (individual connection) or from one of our 13 auditoriums. The auditoriums are located in several different cities, distributed across Latin America, and include: La Paz and Santa Cruz, in Bolivia; Villavicencio, Ibagué, Bucaramanga, Medellín, Bogotá, Cartagena, Barranquilla and Neiva, in Colombia; Guayaquil, in Ecuador; Monterrey, in Mexico; and Mérida, in Venezuela.

This year's big innovation was the upgrade of the virtual learning space. The system enhancement meant a significant improvement in the transmission quality, thereby facilitating an even better interaction between Faculty members and participants.

"In my opinion, the Virtual Courses are a very important and interesting activity, especially for those situated in geographically remote locations. In order to maintain the success of the activity and ensure the ongoing enthusiasm of the participants, it is important that some key points are met:

- 1. An effective operational system, closely supported by a strong team;
- 2. Constant support from the AOSLA Office;
- 3. Interest and time from the Faculty;
- 4. An adequate and dynamic program for the activity, which draws the participants' attention;
- 5. Effective work coordination, as it takes time to elaborate the materials.

The future of the project is deeply connected to our ability to maintain the high level of operational effectiveness and quality, such as we have been doing so far."




AOSpine 10 years
